Filing an OCR Complaint

What to Include in a Complaint?

- Basic info re student age, grade, type of disability, how disability impacts him/her
- Allegation failure to implement; procedural defect; other different treatment
- Facts supporting/related to the allegation
- What you believe is an appropriate remedy/outcome and why

Filing an OCR Complaint Cont'd

If you write your own letter/email, please include:

- Name, address and, if possible (although not required), a telephone number and email
- Information about the person(s) or class of persons injured by the alleged discriminatory act(s);
- The name and location (city and state) of the institution that committed the alleged discriminatory act(s); and
- A description of the alleged discriminatory act(s) in sufficient detail to enable OCR to understand what occurred, when it occurred, and the basis for the alleged discrimination.
